7. Financial Report

- Jess shared notes for Budget sheets (with Chris technically in transition as Treasurer)
 - Cable income trending on budget.
 - Grants income line about to go un significantly. VAN secured 600K in state budget (Media Factory will receive 25K) for community media. Real positives for community media with their legislative work (bridge funding for some of the cable losses).
 - Production income has been doing well. 8K additional billing not reported in this budget. Graduation season was another fantastic success!! (nine graduations last week)
 - Program fees also doing very well (VT Arts Council, fee for service projects)
 - Trending lower in payroll (Some turnover; one part-time person promoted to full time-Nora; 1-2 part-time production positions may also be hired in the coming months; it will increase with graduations)
 - Education line includes conference spending
 - Over in bank interest income service charges (include invest account fees; may need to create a new account for new expenses in next year's budget)

- Trending low in consultant line (considering using some money for marketing consultation; also consultation for planning for grant writing, may discuss with board in July to consider using some matching funds)
- Chris shared that all looks very good and he extends his appreciation at the grants income included in this budget category; also kudos with production and program fees increase; repairs and maintenance also appears to be on-target and looking very good. Interest income investment charges need to be addressed moving forward (LINE 4300).
- Deb moved to approve to accept the financial report. Eric seconded. Budget report was unanimously approved.
